OVER-AGE DEPENDENT COVERAGE



Policy N° - 158000

Over-Age Dependent Coverage

If a dependent child has reached the coverage age limitation of 21 years of age or 25 years of age if they attended an accredited school, college, or university as a full-time, plan coverage may be extended in the event of a dependent child's disability.

Eligibility Requirements

- The dependent child must be
 - Incapable of supporting themselves due to physical or cognitive disability,
 - Become incapacitated prior to the coverage age limitation, and
 - Is chiefly dependent upon the Member for support and maintenance.
- Proof of disability must be supported by a licensed physician (M.D.) in Canada.
- Proof must be submitted to the Administrative Agent as required but not more often than yearly.

Benefit

- Continuation of Extended Health, Vision Care, Dental Care, Emergency Out of Province Medical, and Hospital Cash benefit coverages.

Application Instructions

1. Ensure you meet the eligibility requirements for this benefit listed above.
2. Plan Member to complete Parts 2, 3, and 5 of the Application for Over-Age Dependant Coverage Form.
3. Attending Physician to complete Part 4 of the Application for Over-Age Dependant Coverage Form.
4. Include any supporting medical records.
5. Return the completed application to LiUNAcare Local 183 Member Health Management Services by
